#### Accountant's Report – Closing our 2021

Kathy Berry provided reports covering year end information for both the General Fund and Highway Fund. Overall the Town is in excellent shape financially. She also provided a list of necessary transfers to balance all 2021 accounts. If these transfers are approved by the Board she will update all accounts and provide the final Financial Reports at next month's meeting. She advised that the CLASS revenue line is paying a good percentage and she requested she be allowed to transfer additional funds into this program. This is an investment only available to municipalities and the monies can only be transferred in and out. Interest is compounded on a daily basis. After discussion the Board approved this request at her discretion.

## **Possible Code Enforcement Officer Applicant**

Ryan Reed attended the meeting. He has been a code officer for the City of Olean for 5 years and presently handles 6 municipalities. He is also Assessor for the Village of Cuba. He would consider our appointment with the understanding that he is extremely busy. Discussion about the possibility of appointing him to handle our "problem cases" and then hiring another individual to handle the smaller building projects.

#### **REPORTS**

- Supervisor's Report for March and April 2022 was provided along with information on Fire Protection, Payrolls and Bank Reconciliation. These were reviewed by the Board. Town Clerk presented the following reports:
  - Clerk's Report for the month of April shows \$395.00 collected. \$255 was turned over to the Town Supervisor for the General Fund; \$26 was sent to NYS Ag and Markets for dog licenses, and \$114.00 was sent to Allegany County DPW for landfill tickets sold.
  - Petty Cash Report for April indicates that \$100 is available. No monies were used.
  - The Clerk e-mailed the April minutes to the Town Board for review.

Town Justice Report April 2022:

• Review of Court Fines collected during April totaled \$887.00.

#### Code Enforcement Officer Report:

Code Enforcement Officer Krist did not attend the meeting and no report was submitted.
 Clerk provided a list of one permit application received in April which is on hold pending receipt of building drawings.

Buildings & Repairs – Holcomb and Smith

- Supervisor advised that the Revitalization Grant for the Genesee Library is pending. Highway Department Holcomb and Windus
  - Highway Superintendent Reynolds advised that the addition is all done except for tile in the handicapped bathroom.
  - The Salt barn is presently on hold pending road repairs.
  - The FEMA application is still in process. Continues to be all virtual meetings.

Cemeteries – Holcomb and Estabrook

- Attorney Firkel provided his recommendations if the Town decides to continue
  installment agreements for purchasing graves. After discussion the Board decided to
  continue to offer this to individuals purchasing graves in our cemeteries. Town Clerk
  will revise the agreement form. Also the costs relating to our cemeteries was discussed
  and will be re-visited at Budget time.
- Supervisor Smith spoke with the Small family regarding moving the grave at Bowler Cemetery. The daughter advised she is still aware of the issue and intends to pay the costs previously discussed.
- Clerk advised that the NYS DOT recently took down the large pine tree in the front of Wells Cemetery.

#### **OLD BUSINESS**

# Update on ARP (American Rescue Plan) Funds

- Supervisor Smith provided a copy of the order for 5 computers and 5 microsoft licenses from CDW Government. This totals \$5,616.67.
- CP Windus has looked into materials for replacing the roof on the old section of the Highway Barn. Discussion if this should be a rubber or a metal roof. The metal roof would be more expensive but would have a longer life. He will prepare specs and the town can ask for bids for both rubber and metal roofs.

## Suggested Solar Law

Attorney Firkel has provided copies of 3 local laws for the Towns of Allegany, Alfred and Avoca to be used to help the Board devise their own law. Supervisor Smith asked that the Board Members review these laws and make recommendations to him regarding the pros and cons. Also,

discussion about doing an Energy Law which would cover both solar and wind. It is anticipated that a suggested law be available for the June board meeting.

## <u>Update on Solar Project on State Route 305</u>

The Town received a copy of a letter from Portville School District to Delaware River Solar asking for a proposed PILOT agreement regarding this project.
