Accountant's Report – Closing out 2021

Kathy Berry was scheduled to bring the final 2021 paperwork for discussion. However, due to a family emergency she was unable to attend.

REPORTS

• Supervisor's Report for May 2022 was provided along with information on Fire Protection, Payrolls and Bank Reconciliation. These were reviewed by the Board.

Town Clerk presented the following reports:

- Clerk's Report for the month of May shows \$507.25 collected. \$425.25 was turned over to the Town Supervisor for the General Fund; \$25 was sent to NYS Ag and Markets for dog licenses, and \$57.00 was sent to Allegany County DPW for landfill tickets sold.
- Petty Cash Report for May indicates that \$100 is available. No monies were used.
- The Clerk e-mailed the May minutes to the Town Board for review.

Town Justice Report April 2022:

• Review of Court Fines collected during May totaled \$180.00.

Code Enforcement Officer Report:

- Code Enforcement Officer Krist has officially resigned his position and has returned all paperwork to the Town Clerk. Clerk provided a list of four permit applications received in May.
- Suggestion made that new road signs be purchased stating "Building Permit Required" for the town roads. Superintendent Reynolds will check on the prices. Highway employees would install them.

Dog Control Officer:

A quarterly report covering April, May and June 2022 will be prepared for the July Board meeting. However, Mr. Wagner wanted to discuss some issues with the Board:

- He requested that the town make arrangements for a local Vet to be used in an emergency situation. After discussion, Supervisor Smith will contact Haskell. Valley Vet Clinic regarding this.
- Also requested help with the water at the dog kennel. What is there now does not
 work properly and needs to either be repaired or replaced. Highway
 Superintendent Reynolds will look at the present pump and see what could be

done. He will advise Supervisor Smith if he feels we should hire someone to look at the problem.

Motion made by CP Holcomb and 2^{nd} by CP Miller to accept all reports as submitted. Ayes all. Motion carried.

Buildings & Repairs – Holcomb and Smith

• Quote from JCK Carpet Cleaning has been received for cleaning of the Town Hall on a monthly basis. CP Miller made a motion, 2nd by CP Estabrook, that this quote be approved.

Highway Department – Holcomb and Windus

- The FEMA application is still in process. The projects have been approved verbally, with no Town monies needed.
- CP Windus recommended specs for the Highway Barn roof replacement. After discussion and some adjustments, these specs were approved. Town Clerk was instructed to advertise for bids in the Olean Times Herald. The bids are to be received through Tuesday, July 19, 2022 until 12 Noon. Bids will be opened at the July Board meeting.
- CP Miller asked Superintendent Reynolds about the condition of School Street in Ceres. It is on the schedule to be worked on later this week.

• It has come to our attention that an updated driveway is needed in the West Genesee Cemetery so people know where to drive. A quote has been presented by Scott Fuller to do a horseshoe driveway in the new section. After discussion a motion was made by CP Windus, 2nd by CP Miller, that this quote be approved.

• As there are building projects being done without building permits, Highway Superintendent suggested new signs on Town roads which would say, "Building Permit Required". This was tabled so that Mr. Reynolds can check on the prices for these signs.

OLD BUSINESS

<u>Update on ARP (American Rescue Plan) Funds</u>

- Computers have been received which will be paid for with ARP monies and will be installed by Supervisor Smith as soon as possible.
- Resolution #2022-14 was presented by CP Holcomb, 2nd by CP Miller as follows:

RESOLUTION TO DONATE MONIES TO GENESEE LIBRARY FROM AMERICAN RESCUE PLAN ALLOTMENT **WHEREAS,** The Genesee Library is in need of outside painting and the Library Board has requested additional monies from the Town to cover this cost;

WHEREAS, The Library provided essential services to Genesee Town residents during the COVID pandemic. At a Town Board meeting held April 26, 2022 the Board approved the use of American Rescue Plan (ARP) monies to be used for this purpose.

NOW THEREFORE, the Town Board approves the additional donation of \$22,000.00 to the Genesee Library for the purpose of funding the outside painting of the building. Said monies will be paid from the ARP funds available.

She shall have full authority to exercise and perform any of the powers and duties of the Clerk/Tax Collector/Registrar that may be specified by the Town of Genesee. Position to be paid at the New York State minimum wage of \$13.20 .

Updated Election Information for 2022

CP Windus will be on the ballot to fill a vacancy created by the resignation of Joshua Bluhm. CP Estabrook failed to meet the deadline for the ballot so will be hoping she will receive write-in votes for the vacancy created by the resignation of Howard Cornwall. Due to the resignation of Town Clerk Brunner, it is anticipated that the Republican committee persons will nominate Rhonda Faulkner to be on the ballot to fill the Town Clerk vacancy.
