RESOLUTION NO: 2024-7

RESOLUTION ADOPTING THE PRO-HOUSING COMMUNITIES PROGRAM TO ADDRESS HOUSING IN THE TOWN OF GENESEE

WHEREAS, the Town of Genesee believes that the lack of housing for New York residents of all ages and income levels negatively impacts the future of New York State's economic growth and community well-being;

WHEREAS, the housing crisis has negative effects at regional and local levels, we believe that every community must do their part to contribute to housing growth and benefit from the positive impacts a healthy housing market brings to communities;

WHEREAS, we believe that supporting housing production of all kinds in our community will bring multiple benefits, including increasing housing access and choices for current and future residents, providing integrated accessible housing options that meet the needs of people with sensory and mobility disabilities, bringing economic opportunities and vitality to our communities, and allowing workers at all levels to improve their quality of life through living closer to their employment opportunities;

WHEREAS, we believe that evidence showing that infill development that reduces sprawl and supports walk able communities for significant environmental and public health benefits; and

WHEREAS, we believe that affirmatively furthering fair housing and reducing segregation is not only required by law, but is essential for keeping our community strong and vibrant;

NOW, THEREFORE, IT IS HEREBY RESOLVED, THAT the Town of Genesee, in order to take positive steps to alleviate the housing crisis, adopts the Pro-Housing Communities pledge, which will have us endeavor to take the following important steps:

Streamlining permitting for multifamily housing, affordable housing, accessible housing, accessory dwelling units, and supportive housing.

Adopting policies that affirmatively further fair housing.

Incorporating regional housing needs into planning decisions.

RESOLUTION NO: 2024-8 July 16, 2024

RESOLUTION ADOPTING THE ACTIVE COMMUNITIES ACTION PLAN FOR CONNECTING ACTIVITY-FRIENDLY ROUTES TO EVERYDAY DESTINATIONS IN THE TOWN OF GENESEE

WHEREAS, The Allegany County Department of Health provides public health services in Allegany County New York, including the Town of Genesee. The agency is working to bring together a cross-sector team of community members, policy makers, and agencies to ensure an action plan is completed to solidify the vision for increasing physical activity through community design. Access Allegany, as a public transportation provider in Allegany County, is working to improve access to and use of public transportation in towns across Allegany County, NY. This action plan is for the Hamlet of Little Genesee and it covers a five-year period, starting in September 2026.

WHEREAS, the project team members for this plan will include the Town of Genesee Board, the Allegany County Department of Health, Allegany County Access Allegany, Allegany County Planning Department, and the Little Genesee Library;

WHEREAS, the Town of Genesee has a population of 1,633 is in the southwestern corner of Allegany County, NY and has a land area of 36.3 square miles. The Hamlet of Little Genesee is located within the Town of Genesee on Route 417 in the eastern part of town. Census data shows 780 housing units in the Town of Genesee and based on Allegany County records of parcel data and assessments, there are 28 residential properties within .25 miles of the park. State Route 417 serves as the main street running East & West through the hamlet with no bicycle lanes or sidewalks and one bus stop heading West in front of the Town Hall.

The vision for Little Genesee is to provide residents with an environment that is conducive for healthy lifestyles and living by providing access to outdoor physical and recreational activities, including the Little Genesee Library, Bolivar Golf Course and Clubhouse, and Town Park. To achieve this vision, the following specific goals have been identified:

• Develop one safe walking and bicycling trail(s) within the community of Little Genesee by 2028.

- Access Allegany will add one additional bus stop by the Little Genesee Library and provide public transportation into and out of Little Genesee along Route 417 East and West to meet the needs of the community by 2028.
- Excavation and renovations to the Public Park will increase usable land by 50%, current usable acreage is 25% within the park boundaries. Other necessary improvements will include ADA compliant? parking, seating, pathways, . Installation of additional benches, new playground equipment, signage, dusk to dawn lighting, and security cameras.

The Action Plan (developed in 2024) lays out the strategy for this project over the next 5 years and will be reviewed and updated annually in April.

Goal 1 (Street Design & Connectivity) – Develop one safe walking and bicycling trail(s) within the community of Little Genesee by 2028

Action 1 - Determine location and type of trail.

Responsible Project Team Members - Town of Genesee, Little Genesee Library, Allegany County Planning, Residents w/lived experience
Timetable - Begin process Spring 2026 and Complete Fall 2028
Metrics/Deliverable - Location and type of trail determined.

Action 2 – Identify considerations to accessibility, safety, and optimal usage including signage, lighting, connectivity, and access to destinations (Library, Town Hall, Golf Course, Public Park, Fishing Access).

Responsible Project Team Members - Town of Genesee, Library, Golf Course, DEC – Fishing Access, Highway Dept., right of ways, residents, and Allegany County Planning department. Timetable – Begin Spring 2027 and complete Spring 2028

Metrics/Deliverable – Signage, lighting, and accessibility measures are made for trail.

Goal 2 (Public Transportation) – Enhance public transportation into and out of Little Genesee along Route 417 East and West to meet the needs of the community by 2028.

Action 1 – Conduct public awareness campaign of public transportation system operation in collaboration with existing resources town hall, town website, library, library website, post office, and social media campaign.

- Responsible Project Team Members Access Allegany, Town of Genesee, Little Genesee Library, Little Genesee Post Office
- Timetable Begin Spring 2025 and Ongoing
- Metrics/Deliverable Community member ridership numbers and usage of the public transportation system increases.

Goal 3 (community concerns) - Actively look for funding resources to address projects that will address community safety and mobility and promote improve health equity.

Action 1 - Submit one funding application annually that addresses the goals outlined in this plan.

Responsible Project Team Members - Town officials. Timetable - Third Quarter 2025 Metrics/Deliverable - Funding application is completed and submitted.

Supervisor Alex Smith, 2nd by CP Miller made a motion to accept this resolution.
