National Fuel Gas Distribution Corporation- Notice of claim – The Town received a bill for the gas line the Highway Department hit when cleaning ditches on Wells Road July 24, 2024 at 9.45 a.m.. Highway Superintend Superintend Ben Reynolds stated it was his fault as he did not call 811 U- Dig. Supervisor Smith highlighted that the Superintendent was not the person operating the equipment at the time and according to U-DIG training the operator of the equipment can be held liable. It was also noted that all of the Highway Department employees have participated in the U-DIG training provided Allegany County this year.

There was a discussion regarding the need for expanded communication between the Highway Superintendent and the Town Supervisor when similar type events happen th the future and a need to comply with all legal requirements.
